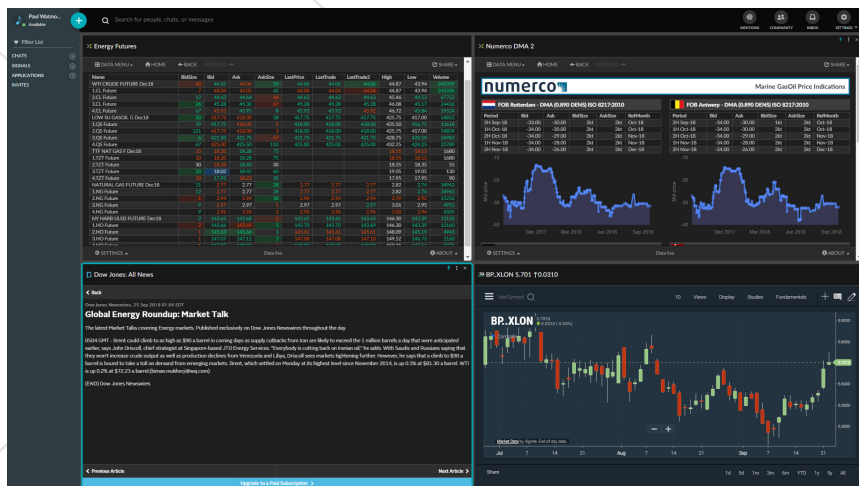

Display realtime data from your market data or messaging platforms directly within Symphony

For specified user groups, this enables Symphony to become a low-cost alternative to a proprietary market data terminals. Only permissioned users can retrieve data which ensures compliance with, for example, your Exchange obligations etc.

Incorporate 'ticking' realtime data directly within a chat using the MDXT Inline Data Bot

Facilitates discussions of one or more instruments within a chat, with data updating inside the chat window as the conversations progress.

Share all internal data types by publishing to the MDXT Connect Server caches

Publish data types that can be represented as records and fields, to permissioned users, into the caches and message queues (e.g. from Excel). This includes project status information, support ticket status, holiday calendars, work rosters or anything else that needs to be widely distributed to groups of users.

Create interactive workflows between Excel and Symphony users via 'pages' on Symphony and the MDXT Connect Excel add-in

As well as 'display only' pages, the MDXT Symphony App supports interactive pages, where one or more 'cells' on the page can be edited directly within Symphony by permissioned users. These changes can be shared with both Symphony and MDXT Connect Excel add-in users working on the same set of shared data.

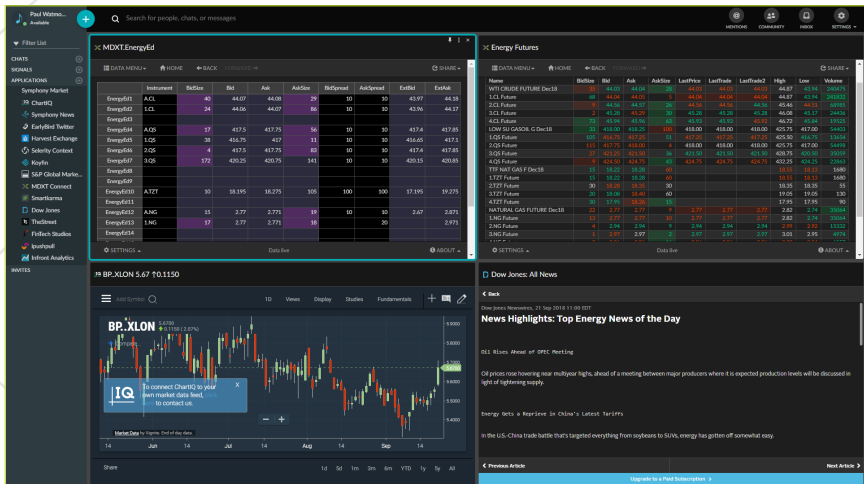
